**PRECAUTIONS**

- Avoid prolonged contact with concentrated product.
- In the case of contact, wash affected area with soap and water.
- In case of contact with eyes flush immediately with water for at least 10 minutes.
- Rinse empty container three times with a volume of water equal to at least 10% of that of the container and add the rinsings to the contents of the spray tank before disposing of the container in the prescribed manner.
- Destroy empty container by perforation and flattening and never use for any other purpose.
- Prevent contamination of food, feed, drinking water and eating utensils.

**DIRECTIONS FOR USE: Use only as indicated.**

Mix **TENDERBUFF** with the spray water before adding any other agricultural remedies.

**TENDERBUFF** is recommended at a rate of 50 mL/100 L water.
